## Advisory

It has been observed that there are instances of blocking of multiple packages under General Surgery and Gynaecology packages like Adhesiolysis in addition to the primary planned surgery in Swasthya Sathi.

Whereas, in common Medical Management cases, treatment is being done for a considerable prolonged period.

Accordingly, the following instructions are to be followed:

- i. For planned General Surgery like Laparoscopic or Open Cholecystectomy, Appendicectomy & in Gynaecological procedures like Abdominal or Vaginal Hysterectomy, no additional package can be blocked, and all treatments needs to be covered under the existing package.
- ii. In case of common Medical management cases, where prolonged stay of IPD cases which are admitted more than 10 days, it must be referred to Medical Audit team for further review.

In case of any default, penalty/action will be initiated against ISA, treating doctor and concerned hospital.

This is issued for patient safety and proper utilization of Swasthya Sathi scheme with immediate effect.
